 - iv. Lifting of cement foundation by back playground door One quote was received from ACI for just under \$3,000. Brockman and Cotten are going to work on requesting additional quotes from other vendors and will report back to the board.
 - v. Replacement of exterior security lights on 500 building Two quotes were received one from Schmidt Electric and one from River Road Electric. After dissecting the bids, the board decided to move forward with Schmidt Electric. Motion to approve the quote and move forward with the project made by Freese, 2nd by Savage. Motion carried unanimously.
 - vi. Replacement of exterior window above chapel doors Motion to approve the single \$1500 quote received made by Freese, 2nd by Cotten. Motion carried unanimously.
