## Introduction and Voter Eligibility

This Voting Guide will give everyone in the Swan River community information on all the candidates to assist in the election voting.

### \*\*\*<u>No one may have more than one vote.</u>

Voter eligibility will be limited to:

 $\checkmark$  Any parent (natural, step, or foster) or any legal guardian of a student enrolled at SRMCS shall have one vote.

✓ All SRMCS staff members employed at the school, including teachers providing instruction under a cooperative, shall have one vote.

## The Overall Function of the Board

Board members have both a legal duty and ethical obligation to ensure that SRMCS carries out its mission, vision, and goals. The SRMCS Mission Statement reads as follows: The mission of Swan River Montessori Charter School is to provide a child-centered environment for self-directed and personalized learning in a small, community-based public school with an emphasis on the natural environment. Therefore, as part of the Board of Directors, individual board members should think of themselves as stewards of the school – responsible for the long-term viability of SRMCS. Whether a parent, teacher, or community member, Directors do not represent particular constituencies, but rather, focus on the overriding interests and welfare of SRMCS.

# **Board Structure and Open Seats**

To be in compliance with our Bylaws (Bylaws posted at <u>www.swanarivermontessori.org</u>), The Board of Directors shall consist of not less than five (5) non-related nor more than nine (9) members. We must have at least one (1) parent/legal guardians, at least one (1) teachers and one (1) community member to fill roles on our Board. These are briefly defined as follows:

✓ **Community Member:** An individual with an interest in quality education who does not have a child attending the school, nor is employed by the school.

✓ **Parent/Legal Guardian:** An individual who is a parent or legal guardian of a currently enrolled student at SRMCS.

✓ **Teacher:** An individual who is currently employed as a licensed teacher at SRMCS.
